



CONSOLIDATED MULTI-YEAR BILLING PROPOSAL ACCEPTANCE (“MULTI-YEAR CAB”)

1 OCTOBER 2018 TO 30 JUNE 2021

1. On behalf of NSW Department of Justice ABN 11 005 693 553 representing the NSW Justice Consortium (comprising the agencies listed in the NSW Justice Consortium Schedule) (“**Customer**”), I accept the terms of Thomson Reuters’ Multi-Year CAB as set out below and agree to pay the amounts specified below for the period 1 October 2018 to 30 June 2021 (“**Contract Term**”).

2. I have read the Thomson Reuters **Thomson Reuters Terms of Trade (v13 – 04/15)**, **Online Addendum (v4 – 09/16)**, **Westlaw Global Addendum (v2.2 – 08/16)** (that together with this document, including the Discount Schedule, comprise “**the Agreement**”). I accept and agree on behalf of the Customer that this Agreement, as varied by the terms expressed in clause 7 below headed “Special Conditions” applies to the Customer’s purchase of the products and services listed in the attached schedule (“**Schedule**”) and to any orders made by the Customer for additional products and services (in addition to those listed in the Schedule), during the Contract Term.

3. The Customer shall pay the following amounts (“**Annual Subscription Fees/ASF**”) during the Contract Term in respect of the products and services listed in the attached Schedule for each twelve-month period during the Contract Term (“**Contract Year**”):

Part Contract Year 1: (1 October 2018 to 30 June 2019)	\$1,687,076.13 including GST (272 days pro-rata of the ASF \$2,263,907.31)
Contract Year 2 (1 July 2019 to 30 June 2020)	\$2,320,504.90 including GST
Contract Year 3: (1 July 2020 to 30 June 2021)	\$2,378,517.50 including GST

4. The Customer may extend the Contract Term for two further 1 year terms by providing Thomson Reuters with written notice at least 60 days prior to expiry of the then current Contract Year. In the event that the Contract Term is extended, the then current Annual Subscription Fee will be increased by 2.5% for the duration of the relevant Contract Year.

5. Payment of the Annual Subscription Fee will be made annually in advance at the commencement of each Contract Year within 30 days of the date of invoice.

6. If the Customer orders subscription products or services (other than those listed in the Schedule, including for example, but not by way of limitation, as a result of the appointment of a new judge) during a Contract Year, Thomson Reuters will issue a pro-rata invoice at the time of purchase in respect of the percentage of the annual subscription charge for those products and services for the balance of that Contract Year. The full annual subscription charge for the additional products and services will be added to the Annual Subscription Fees in the subsequent Contract Years for the remainder of the Contract Term. No postage and handling charges are applicable in relation to the additional books purchased pursuant to this clause.
