Targeted Early Intervention (TEI) services - year to date (YTD) data

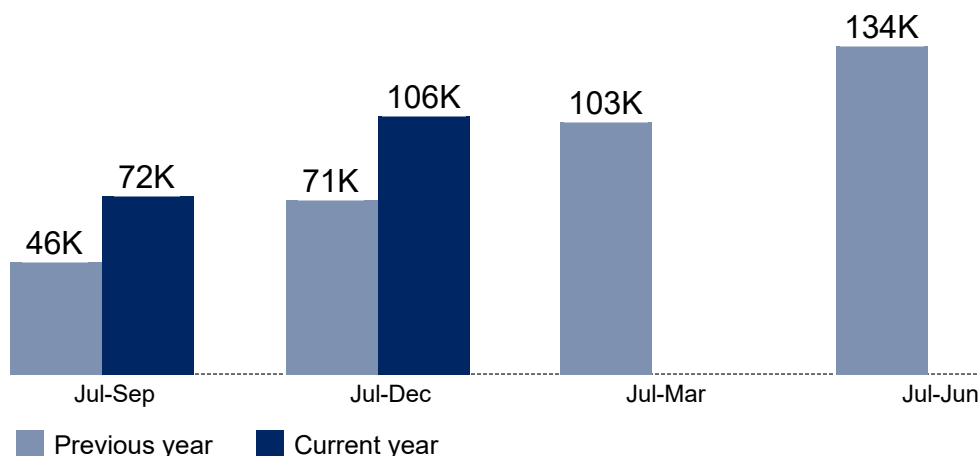


How many **individual clients** were seen in TEI from the first day of the financial year to the end of the quarter?

Chart 1: TEI - Individual clients seen (YTD)

There were approximately **106K** individual clients who received TEI services from 1 July 2022 to 31 December 2022.

When compare with the same period in the previous year of **71K** individual clients who received TEI services, this is an increase of approximately **35K**.

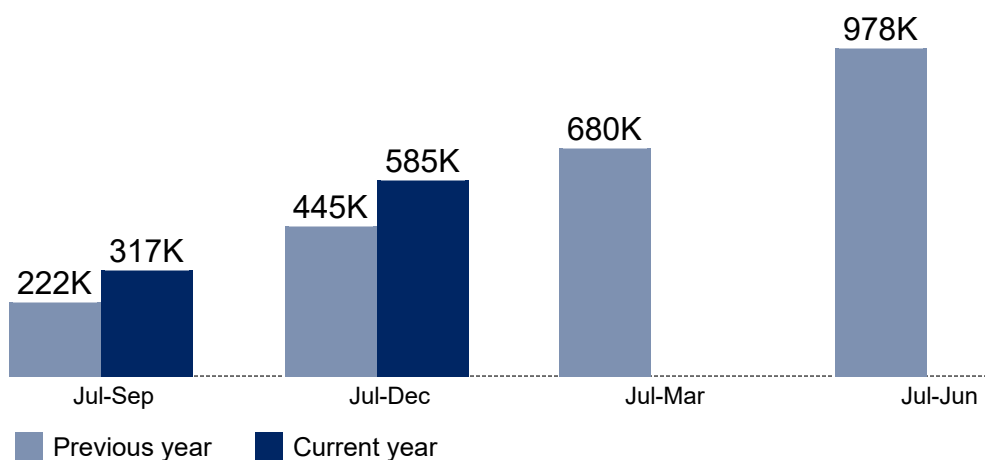


How many **group clients** were seen in TEI from the first day of the financial year to the end of the quarter?

There were approximately **585K** group clients who received TEI services from 1 July 2022 to 31 December 2022.

When compare with the same period in the previous year of **445K** group clients who received TEI services, this is an increase of approximately **139K**.

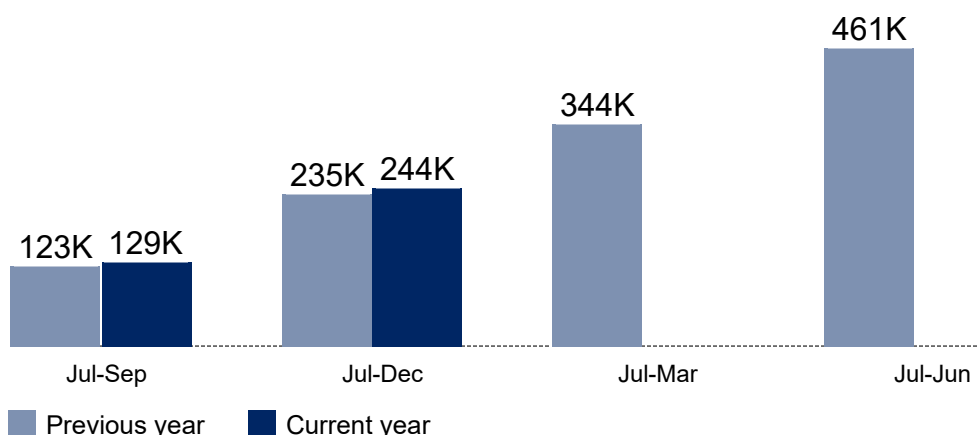


How many **total sessions** were delivered in TEI from the first day of the financial year to the end of the quarter?

There were approximately **244K** TEI sessions delivered from 1 July 2022 to 31 December 2022.

When compare with the same period in the previous year of **235K** TEI sessions delivered, this is an increase of approximately **9K**.

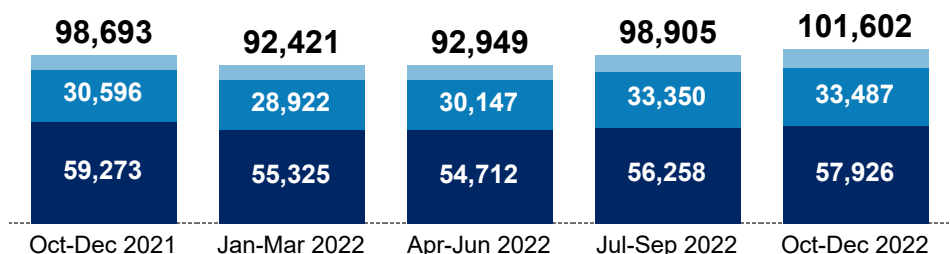

A total of **101,602** child and young person concern reports were received in the October to December 2022 quarter. Of these concern reports reported in the quarter,

- **57.0%** met the risk of significant harm (ROSH) threshold,
- **33.0%** were assessed as not meeting the ROSH threshold, and
- **10.0%** were classified as other.

Meeting ROSH threshold Not meeting ROSH threshold Other



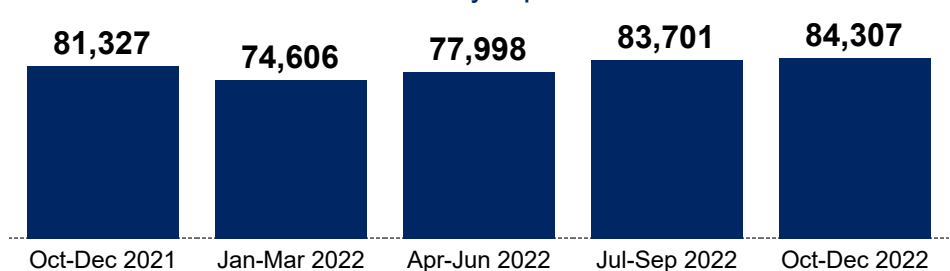

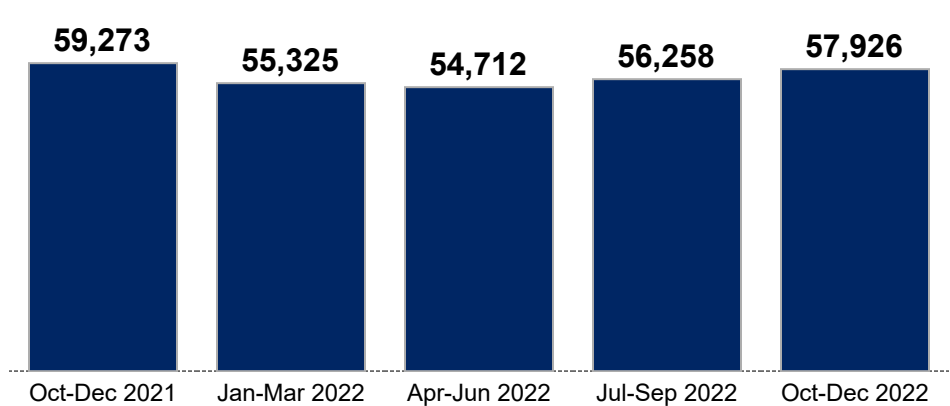

Chart 3: **ROSH reports** by primary Helpline assessed issue

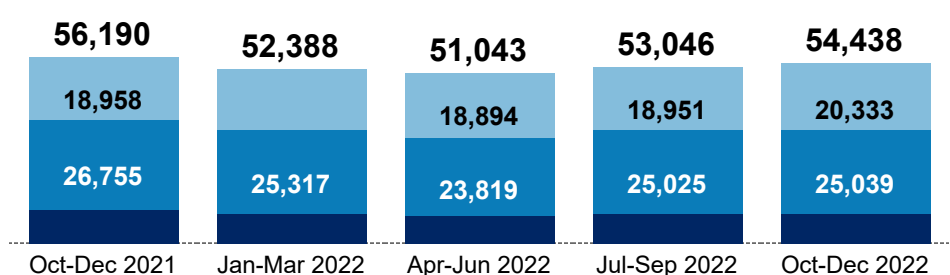

Determining a response time for **ROSH reports** from mandatory and non-mandatory reporters

Of the 57,926 ROSH reports reported to the DCJ Child Protection Helpline in this quarter,

- 9,066** reports were classified as requiring a response in 24 hours
- 25,039** reports were classified as requiring a response in 72 hours
- 20,333** reports were classified as requiring a response in 10 days.

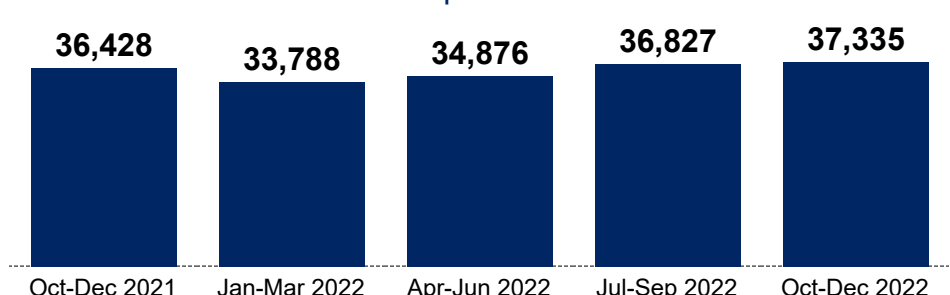


Child and young person **contacts** by mandatory reporters to the DCJ Child Protection Helpline

Children and young people involved in concern reports

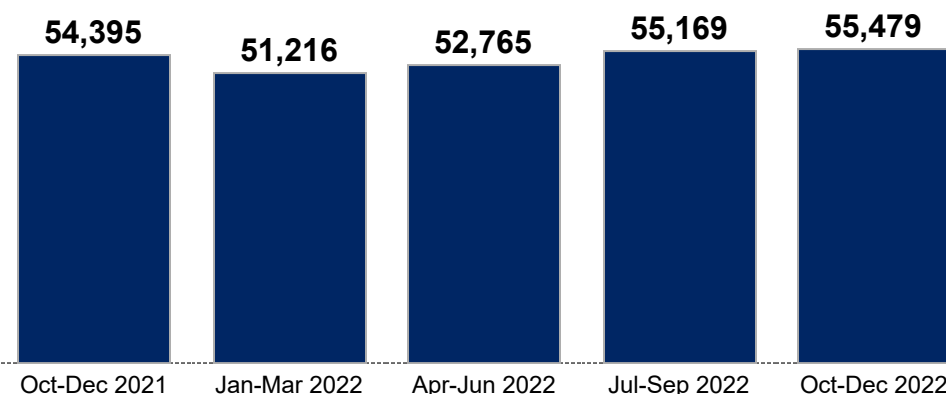


How many **children and young people** were involved in child and young person **concern reports** during the quarter?

There were **55,479** children and young people involved in concern reports in the October to December 2022 quarter, an increase of **0.6%** from the previous quarter.

When compared with the same quarter in the previous year of **54,395**, this is an increase of **2.0%**.

Chart 1: **Children and young people** involved in concern reports



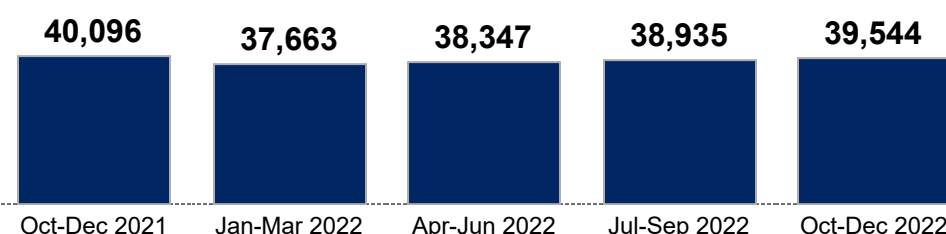
How many **children and young people** were involved in **ROSH reports** during the quarter?

A total of **39,544** children and young people involved in ROSH reports in NSW in the October to December 2022 quarter. This represents a rise of **1.6%** from the previous quarter.

When compared with the same quarter in the previous year of **40,096**, this is a decrease of **1.4%** or **552** children and young people.

Chart 2: **Children and young people** involved in ROSH reports² during the quarter



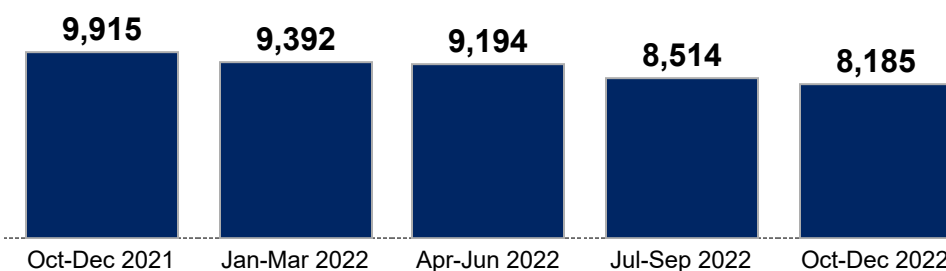
How many **children and young people** were **seen** by a DCJ caseworker during the quarter?

A total of **8,185** children and young people involved in ROSH reports who were seen by a DCJ caseworker in NSW in the October to December 2022 quarter. This translates to a decline of **3.9%** from the previous quarter.

When compared with the same quarter in the previous year of **9,915**, this is a decrease of **17.4%** or **1,730** children and young people.

Chart 3: **Children and young people** involved in ROSH reports during the quarter who were seen³



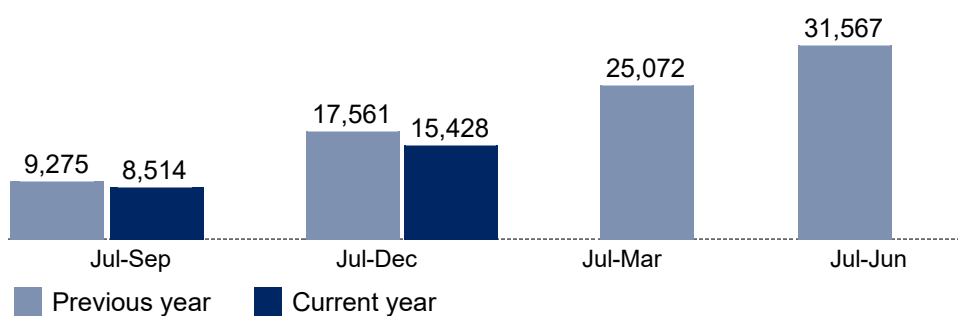
How many **children and young people** were **seen** by a DCJ caseworker from the first day of the financial year to the end of the quarter?

A total of **15,428** children and young people involved in ROSH reports who were seen by a DCJ caseworker from July 2022 to December 2022.

When compared with the same period in the previous year of **17,561** children and young people, this is a decrease of **2,133** children and young people were seen by a DCJ caseworker.

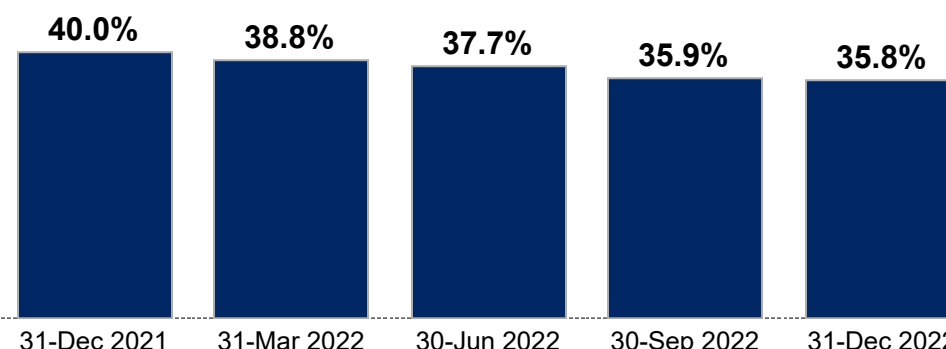
Chart 4: **Children and young people** involved in ROSH reports who were seen YTD



What is the percentage of children and young people re-reported at ROSH within 12 months of case plan closure **by the end of the quarter**⁴?

By 31 December 2022, **35.8%** of children and young people were re-reported at ROSH within 12 months of case plan closure (Target 32.3% by June 2023).

3. District in **Children Seen** measure refers to District associated with the ROSH report during the reporting period that had the earliest submitted Safety/Alternative Assessment.
4. Based on the cohort of children who had closed cases during the 12 month period with case closure reasons of either (i) *case plan goal achieved* OR (ii) *no further intervention required*. These children are followed up for 12 months following care closure to determine what proportion are reported within that 12 month follow up period ending the last day of the reported quarter.

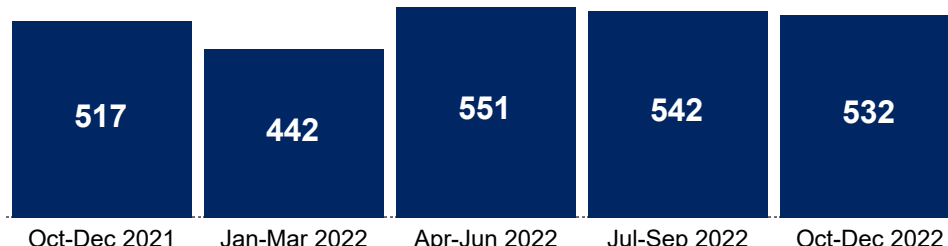
Children and young people entering care during the quarter

A total of **532** children and young people entered OOHC in the October to December 2022 quarter. This represents a reduction of **1.8%** or **10** children and young people, when compared with the previous quarter.

When compared with the same quarter last year of **517** children and young people entering care, this is an increase of **2.9%** or **15** children and young people.

Chart 1: Children and young people entering OOHC⁴ by age at entry



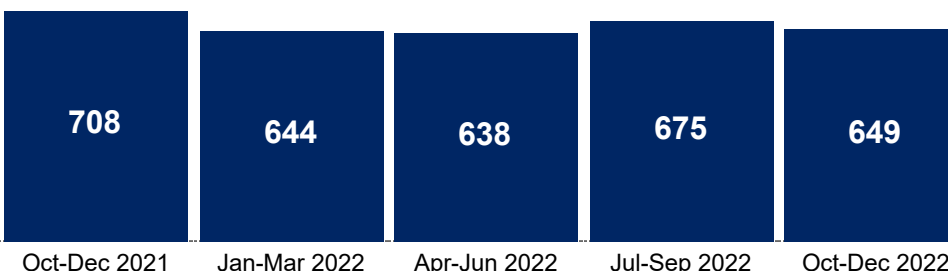
How many children and young people exited OOHC during the quarter?

There were **649** children and young people exiting OOHC in the October to December 2022 quarter. This is a decrease of **3.9%** or **26** children and young people from the previous quarter.

Compared with the same quarter last year of **708** children and young people exiting OOHC, this is a decrease of **8.3%** or **59** children and young people.

Chart 2: Children and young people exiting OOHC⁴ by age at exit



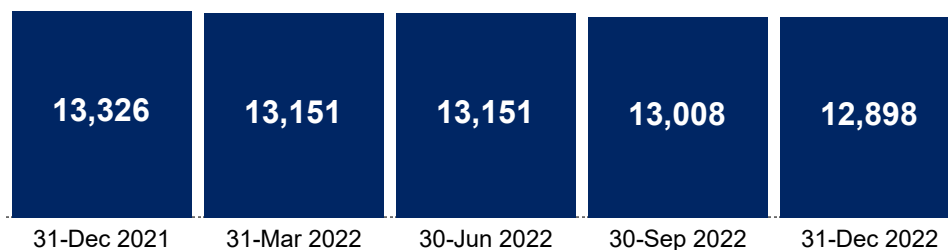
Children and young people in need of care and protection by case management responsibility

Chart 3: Children and young people in statutory OOHC⁴ by Aboriginality and case management responsibility at quarter end

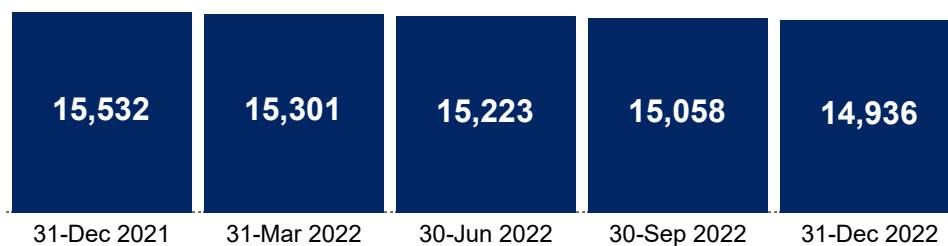


Placement of children and young people in need of care and protection

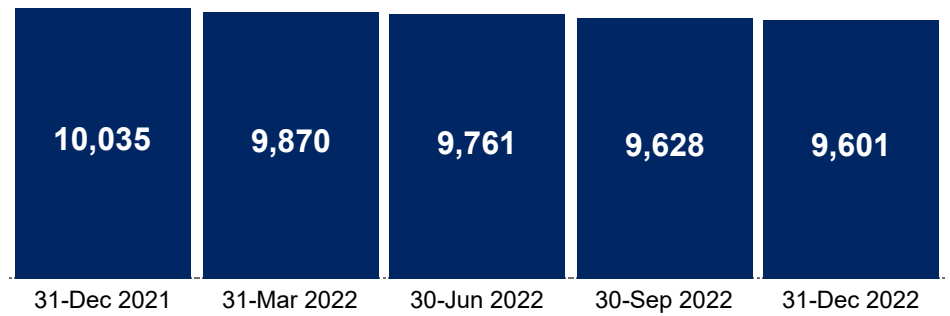

Alternate permanent placement solutions for children and young people in need of care and protection

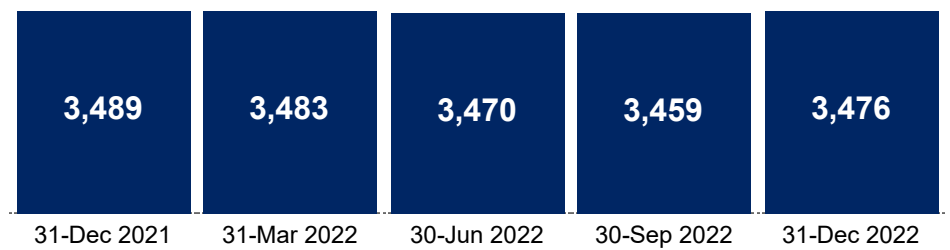

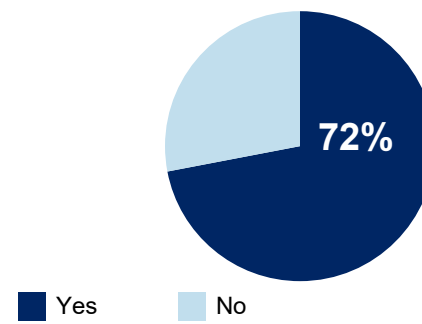
Chart 2: Number of children and young people on Guardianship Orders by Aboriginality and age group
