
Targeted Early Intervention (TEI) services - year to date (YTD) data



How many **individual clients** were seen in TEI from the first day of the financial year to the end of the quarter?

There were approximately **106K** individual clients who received TEI services from 1 July 2022 to 31 December 2022.

When compared with the same period in the previous year of **71K** individual clients who received TEI services, this is an increase of approximately **35K**.



How many **group clients** were seen in TEI from the first day of the financial year to the end of the quarter?

There were approximately **585K** group clients who received TEI services from 1 July 2022 to 31 December 2022.

When compared with the same period in the previous year of **445K** group clients who received TEI services, this is an increase of approximately **139K**.





How many **total sessions** were delivered in TEI from the first day of the financial year to the end of the quarter?

There were approximately **244K** TEI sessions delivered from 1 July 2022 to 31 December 2022.

When compared with the same period in the previous year of **235K** TEI sessions delivered, this is an increase of approximately **9K**.

Child and young person concern reports received from reporter agencies and how these reports were classified


A total of **103,471** child and young person concern reports were received in the January to March 2023 quarter. Of these concern reports reported in the quarter,

- 55.6% met the risk of significant harm (ROSH) threshold,
- 33.5% were assessed as not meeting the ROSH threshhold, and
- 10.9% were classified as other.




Assessment of child and young person concern reports to determine if they meet the statutory ROSH threshold

There were **57,482** ROSH reports in the January to March 2023 quarter. This is equivalent to a decrease of **0.8%** from the previous quarter.

Compared with the same quarter last year of 55,325, this represents a growth of 3.9%.

Determining a response time for **ROSH reports** from mandatory and non-mandatory reporters

Of the 57,482 ROSH reports reported to the DCJ Child Protection Helpline in this quarter,


8,692 reports were classified as requiring a response in 24 hours **25.745** reports were classified as requiring a response in 72 hours **19,976** reports were classified as requiring a response in 10 days.



Child and young person **contacts** by mandatory reporters to the DCJ Child Protection Helpline

The DCJ Child Protection Helpline received 38,352 child and young person contacts in the January to March 2023 quarter. This represents an increase of 2.7% or 1,017 contacts, when compared with the previous quarter. Compared with the same quarter last year of **33,788**, this is an increase of 13.5% or 4,564 contacts.




How many **children and young people** were involved in child and young person **concern reports** during the quarter?

There were **55,243** children and young people involved in concern reports in the January to March 2023 quarter. This is comparable to the number reported in the previous quarter.

When compared with the same quarter in the previous year of **51,216**, this is an increase of **7.9%**.






How many **children and young people** were involved in **ROSH reports** during the quarter?

A total of **39,102** children and young people involved in ROSH reports in NSW in the January to March 2023 quarter This translates to a decline of **1.1%** from the previous quarter.

When compared with the same quarter in the previous year of **37,663**, this is an increase of **3.8%** or **1,439** children and young people.

Chart 2: Children and young people involved in ROSH reports² during the quarter






How many **children and young people** were **seen** by a DCJ caseworker during the quarter?

A total of **8,437** children and young people involved in ROSH reports who were seen by a DCJ caseworker in NSW in the January to March 2023 quarter. This represents a rise of **3.1%** from the previous quarter.

When compared with the same quarter in the previous year of **9,392**, this is a decrease of **10.2%** or **955** children and young people.

How many **children and young people** were **seen** by a DCJ caseworker from the first day of the financial year to the end of the quarter?


A total of **22,269** children and young people involved in ROSH reports who were seen by a DCJ caseworker form July 2022 to March 2023.

When compared with the same period in the previous year of **25,072** children and young people, this is a decrease of **2,803** children and young people were seen by a DCJ caseworker.

Chart 4: Children and young people involved in ROSH reports who were seen YTD






What is the percentage of children and young people re-reported at ROSH within 12 months of case plan closure by the end of the guarter⁴?

By 31 March 2023, **35.0%** of children and young people were re-reported at ROSH within 12 months of case plan closure (Target 32.3% by June 2023).

Children and young people entering care during the quarter

A total of **524** children and young people entered OOHC in the January to March 2023 quarter. This represents a reduction of **1.5%** or **8** children and young people, when compared with the previous quarter.

When compared with the same quarter last year of **442** children and young people entering care, this is an increase of **18.6%** or **82** children and young people.

Chart 1: Children and young people entering OOHC⁴ by age at entry




How many children and young people exited OOHC during the quarter?

There were **700** children and young people exiting OOHC in the January to March 2023 quarter. This is an increase of **7.9%** or **51** children and young people from the previous quarter.

Compared with the same quarter last year of **644** children and young people exiting OOHC, this is an increase of **8.7%** or **56** children and young people.

There were **12,758** children and young people in statutory OOHC at 31 March 2023. Of these 12,758 children, **45.1%** or **5,760** were Aboriginal children and young people.





At 31 March 2023, there were **9,547** children and young people in OOHC with fewer than three placements.

This is equivalent to a decrease of **0.6%** or **54** children and young people from the end of the previous quarter.


A total of **3,460** children and young people were on Guardianship Orders at 31 March 2023.


Chart 2: Number of children and young people on Guardianship Orders by Aboriginalty and age group
