

# 2018 NSW Social Housing Residential Dwellings Dashboard

This accessible document<sup>1</sup> provides a summary of the social housing residential dwellings as at 30 June 2018. It accompanies the interactive online dashboard which is published on the FACS website at FACS Statistics<sup>2</sup>.

# Social housing residential dwellings in NSW as at 30 June 2018

- As at 30 June 2018 the total number of social housing residential dwellings managed in NSW was 151,672. Of these 151,672 residential dwellings, 73.4 per cent or 111,341 residential dwellings were public housing managed and 20.3 per cent or 30,757 dwellings were managed by community housing providers. There were 9,574 residential dwellings exclusively for Aboriginal people.
- Of the 9,574 residential dwellings for Aboriginal people as at 30 June 2018, 4,603 were Aboriginal Housing Office (AHO) managed as public housing and 4,971 were managed by Indigenous Community Housing (ICH) providers.

#### **Public Housing**

- As at 30 June 2018 the total number of public housing managed residential dwellings in NSW was 111,341, which comprised 49,831 units, 40,259 cottages, 13,371 townhouses, 7,836 villas and 44 terraces.
- Of the 49,831 public housing units as at 30 June 2018, 27,949 of all these public housing units were studio/one bedroom, 18,503 of these units were two bedroom, 3,301 of these public housing units were three bedroom and 78 units were four or more bedrooms.
- Of the 40,259 public housing cottages as at 30 June 2018, 38 of these cottages were studio/one bedroom, 7,720 of these cottages were two bedroom, 25,492 of these 40,259 cottages were three bedroom and 7,009 of these cottages were four or more bedrooms.
- Of the 13,371 public housing townhouses as at 30 June 2018, 320 of these public housing townhouses were studio/one bedroom, 3,618 of these townhouses were two bedroom, 8,415 of these townhouses were three bedroom and 1,018 of these public housing townhouses were four or more bedrooms.
- Of the 7,836 public housing villas as at 30 June 2018, 1,685 of these public housing villas were studio/one bedroom, 3,967 of these villas were two bedroom, 2,040 of these villas were three bedroom and 144 of these villas were four or more bedrooms.
- Of the 44 public housing terraces as at 30 June 2018, nine of these terraces were studio/one bedroom, 10 of these terraces were two bedroom, 14 of these 44 terraces were three bedroom and 11 of these terraces were four or more bedrooms.

### **Aboriginal Housing Office**

- The total number of AHO residential dwellings as at 30 June 2018 in NSW was 4,603, which comprised 3,805 cottages, 274 villas, 266 townhouses, 253 units and five terraces.
- Of the 3,805 AHO cottages as at 30 June 2018, studio/one bedroom properties comprised two of these AHO cottages, two bedroom



properties comprised 122 of these cottages, three bedroom properties comprised 2,568 of these cottages, and four or more bedroom properties comprised 1,113 of these AHO cottages.

- Of the 274 AHO villas as at 30 June 2018, studio/one bedroom properties comprised 33 of these AHO villas, two bedroom properties comprised 168 of these villas, three bedroom properties comprised 60 of these villas, and four or more bedroom properties comprised 13 of these AHO villas.
- Of the 266 AHO townhouses as at 30 June 2018, studio/one bedroom properties comprised five of these AHO townhouses, two bedroom properties comprised 75 of these townhouses, three bedroom properties comprised 158 of these townhouses, and four or more bedroom properties comprised 28 of these AHO townhouses.
- Of the 253 AHO units as at 30 June 2018, studio/one bedroom properties comprise 83 of these AHO units, two bedroom properties comprised 124 of these units, three bedroom properties comprised 45 of these units, and only one unit had four or more bedrooms.
- Of the five AHO terraces as at 30 June 2018, three of these terraces were four or more bedroom, one was three bedroom and one was two bedroom. There was no studio/one bedroom AHO terrace.

## **Indigenous Community Housing**

- The total number of ICH managed residential dwellings in NSW as at 30 June 2018 was 4,971, which comprised 4,762 cottages, 111 units, 91 villas, six townhouses and one terrace.
- Of the 4,762 ICH cottages as at 30 June 2018, 23 of these ICH cottages were studio/one bedroom, 201 of these cottages were two bedroom, 3,384 of these ICH cottages were three bedroom and 1,154 of these cottages were four or more bedrooms.
- Of the 111 ICH units as at 30 June 2018, 39 of these units were studio/one bedroom, 61 of these units were two bedroom and 11 of these units were three bedroom. There was no four or more bedroom ICH units.



- Of the 91 ICH villas as at 30 June 2018, two of these villas were studio/one bedroom, 69 of these ICH villas were two bedroom, 16 of these villas were three bedroom and four of these ICH villas were four or more bedrooms.
- Of the six ICH townhouses as at 30 June 2018, two of these townhouse were two bedroom, three of these ICH townhouses were three bedroom and one of these townhouses was four or more bedrooms. There was no studio/one bedroom ICH townhouse.
- As at 30 June 2018, ICH only had one three bedroom terrace.

#### **Community Housing**

- The total number of community housing managed residential dwellings as at 30 June 2018 in NSW was 30,757, which comprised 14,411 units, 8,711 cottages, 4,569 townhouses, 3,049 villas and 17 terraces.
- Of the 14,411 community housing units as at 30 June 2018, studio/one bedroom properties comprised 6,937 of these community housing units, two bedroom properties comprised 6,582 of these units, three bedroom properties comprised 837 of these units, and four or more bedroom properties comprised 55 of these community housing units.
- Of the 8,711 community housing cottages as at 30 June 2018, studio/one bedroom properties comprised 147 of these cottages, two bedroom properties comprised 1,206 of these community housing cottages, three bedroom properties comprised 5,372 of these cottages, and four or more bedroom properties comprised 1,986 of these community housing cottages.
- Of the 4,569 community housing townhouses as at 30 June 2018, studio/one bedroom properties comprised 1,136 of these townhouses, two bedroom properties comprised 1,725 of these community housing townhouses, three bedroom properties comprised 1,477 of these townhouses, and four or more bedroom properties comprised 231 of these community housing townhouses.
- Of the 3,049 community housing villas as at 30 June 2018, studio/one bedroom properties comprised 455 of these villas, two bedroom



- properties comprised 1,912 of these community housing villas, three bedroom properties comprised 634 of these villas, and four or more bedroom properties comprised 48 of these community housing villas.
- Of the 17 community housing terraces as at 30 June 2018, three of these terraces were two bedroom, 11 of these terraces were three bedroom and three of these community housing terraces were four or more bedroom. There was no studio/one bedroom community housing terrace.
